ONEINGAGE DISCLOSURE TEXT ON THE PROCESSING OF SUPPLIER PERSONAL DATA

Pursuant to Law No. 6698 on the Protection of Personal Data ("Law"), your personal data may be processed by "OneIngage" or "Company" as the data controller within the scope described below.

The term "OneIngage" refers to and encompasses OneIngage Pazarlama ve Teknoloji Çözümleri A.Ş., Intechno360 Pazarlama Teknolojileri Anonim Şirketi, and Ingage Dijital Pazarlama Hizmetleri Anonim Şirketi.

Purposes and Legal Grounds for Processing Personal Data

Your personal data collected is collected and processed by our Company based on the following purposes ("Purposes") and legal reasons and the personal data processing conditions specified in Article 5 of the Law.

Based on the legal ground that the processing of personal data belonging to the parties to the contract is necessary and mandatory for the data controller to fulfill its legal obligation, provided that it is directly related to the establishment or performance of a contract;

- Establishment of a supplier business relationship between you and the company you are an employee/authorized,
- Fulfillment of all kinds of obligations arising from your business relationship with our Company.

Based on the legal ground that data processing is mandatory for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject;

- Establishment of a supplier business relationship between our Company and the company you are an employee/authorized person,
- Creation, planning and execution of projects by our company,
- Execution of information security processes,
- Sending commercial electronic messages to your contact information in order to promote and inform you about our products and services and events/organizations organized by the Company.

Based on the legal ground that it is mandatory for our Company to fulfill its legal obligation as a data controller and that it is clearly stipulated in the law;

- Execution of legal processes involving our Company,
- Fulfillment of official institution requests,
- Providing information to authorized institutions due to legislation,
- Ensuring compliance with the custody obligations stipulated in the legislation,
- Responding to data subject applications in accordance with the legislation and taking necessary actions.

To whom and for what purpose the processed personal data can be transferred

Your personal data collected may be transferred to our shareholders within the scope of our legitimate interest, to the consultants we provide services to, to the banks we have contracted with for the purpose of carrying out financial and accounting affairs, to legally authorized public institutions and legally authorized private persons within the scope of the data processing conditions set out in Article 5 of the Law within the scope of the fulfillment of our legal obligations and in accordance with the rules regarding the transfer of personal data specified in Article 8 of the Law.

Method of Personal Data Collection

Your personal data is collected through face-to-face visits and forms filled out by you in the physical environment, e-mail, telephone in the electronic environment, our internal systems, our website and cargo/mail in the physical environment, printed forms and face-to-face interview channels in order to establish and maintain a business relationship between you and our Company.

Rights of the Data Subject under Article 11 of the Law

We inform you that you have the following rights regarding your personal data in accordance with Article 11 of the Law:

- To learn whether your personal data are being processed,
- To request information in case your personal data has been processed,
- To find out the purpose for processing of your personal data and whether they have been used in accordance with that purpose,
- To know the third parties to whom personal data have been transmitted at home or abroad,
- To request for the correction of your personal data if they are incomplete or incorrectly processed and ask that the process carried out in this context be notified to the third parties to whom your personal data have been transmitted,
- Although it has been processed in accordance with the provisions of the Law and other relevant laws, to request the deletion or destruction of your personal data in the event that the reasons requiring its processing disappear and to request notification of the transactions made within this scope and in case your personal data is incomplete or incorrectly processed to third parties to whom your personal data has been transferred,
- To object to any unfavorable result suffered due to analysis of your processed data exclusively by means of automatic systems,
- To demand indemnification of losses suffered due to your personal data being processed in breach of the law.

Your application will be concluded free of charge as soon as possible according to the nature of your request, and in any case within thirty days, at the latest; however, if the transaction requires additional costs, you may be charged according to the tariff set by the Personal Data Protection Board.
